

REGISTRATION OF COMPANIES INTERESTED IN THE PUBLIC BIDS FOR THE ESTABLISHMENT OF MEXICO'S ISTHMUS OF TEHUANTEPEC GROWTH POLES ("WELFARE GROWTH POLES")

Within the framework of the invitations for international public bids for the establishment of the Welfare Growth Poles (PODEBI), of Coatzacoalcos I, Coatzacoalcos II, Salina Cruz, San Juan Evangelista and Texistepec, published in Mexico's Federation Official Gazette on June 20th, 2023, the Interoceanic Corridor of the Isthmus of Tehuantepec (CIIT) invites all individuals or legal entities, national or foreign, interested in the various bidding procedures to participate through the following:

REGISTRATION OF INTERESTED PARTIES

From June 26th to July 20th, 2023, companies interested in participating in the bidding procedures for the establishment of the aforementioned Poles should send the following completed documents to the e-mail polosdesarrollo@ciit.gob.mx:

1. Registration Form;
2. Non-conflict of interest form, and
3. Evidence of experience and capacity in the operation and maintenance of industrial plants, in accordance with the industries referred in the "Agreement issuing the Declaration of Welfare Growth Poles for a period of at least 10 (ten) years".

Within two (2) business days following the submission of the application to the above mentioned e-mail, in and in case that it does not contain the required information or does not comply with the requirements, the Interoceanic Corridor of the Isthmus of Tehuantepec will warn the interested party, by the same electronic means on one occasion, in order to rectify the omission within the following five (5) business days, counted from the date of the notification of the corresponding requirement.

The Interoceanic Corridor of the Isthmus of Tehuantepec will analyze each of the applications and documents and, in case that they fulfill the requirements, the institution will issue the "Registration of Interested Party". The above will be informed to the Interested Party by means of the aforementioned e-mail.

The CIIT will not grant the "Registration of Interested Party" to whoever:

- a) Submits incomplete Registration Forms;
- b) Submits irregular, inconsistent, incomplete or lacking legal validity information or documents;
- c) Does not submit the documents, clarifications or modifications requested on the dates determined for such purpose, or submits them after the established deadlines;
- d) Does not provide evidence of the legal personality and sufficient representation of those who sign any of the documents requested in the Registration Form;

- e) Does not provide evidence of the requested experience and capacities, or
- f) Does not demonstrate the minimum number of years of experience and capacity required.

The persons who obtain the “Registration of Interested Party”, must send the following documents to the e-mail polosdesarrollo@ciit.gob.mx from July 19th to July 20th, 2023:

- Pass to the Orientation Meeting Request Form, and
- Comprehensive Privacy Notice.

The Interoceanic Corridor of the Isthmus of Tehuantepec will issue the Pass to the corresponding Orientation Session from July 21st to July 24th, 2023, to the Interested Party email.
